- D. Upon successful verification of identity under section 3C, details regarding the contents of the prize draw to which the entrant has been allocated will be provide via electronic mail.



- E. Vouchers provided electronically can be distributed electronically to the nominated email address under section 2A, however some prizes and vouchers may be required to be collected or redeemed at the business premises, or a third-party location within the Peel Region. Notice of this will be provided to the winner.
